The undersigned hereby Petition the Madera County board of Supervisors pursuant to California Water Code Section 34153 for formation of a new California Water District, The BONITA WATER DISTRICT, located in Madera County:

- 1. District Name: Bonita Water District
- 2. Affected County: All lands with proposed district are within Madera County.
- 3. District Acreage: The District would be a total of 9,733 acres.
- District Office: The principal business of the proposed district shall be located at 13507 Road 17, Madera, California 93637.
- 5. District Boundaries: The proposed Bonita Water District (BWD/District) includes 68 parcels in unincorporated western Madera County. There are three separate areas of parcels. The largest of the three, including 47 parcels, is generally bounded by the Fresno River to the north, Road 13 to the west, Avenue 12 to the south, and Road 18 to the east. The second area includes five parcels and is generally bounded by the Fresno River to the north, the Chowchilla Canal to the west, Avenue 12 to the south, and Road 12 to the west. The third area is 16 parcels, generally bordered by Avenue 18 1&frasi;2 to the north, Road 14 to the west, Avenue 17 to the south, and the Berenda Creek to the east.
- 6. District Water Sources: The Bonita Water District will source its water primarily from riparian rights held by lands within the district, water purchased from Madera irrigation District, and flood water from the Fresno, River, the San Joaquin River, and Berenda Creek. These supplies will be utilized for irrigation purposes either directly or through groundwater recharge. Additionally, groundwater supplies will be provided by on-site shallow and deep wells. Landowners within the District intend to continue to work together to build infrastructure projects, such as surface water conveyance pipelines, groundwater recharge basins, and water rights. The intention of the petitioners is to comply with the Sustainable Groundwater Management Act and Groundwater Sustainability Plan and continue to reduce our reliance on groundwater and prevent subsidence.
