RESOLUTION OF BOARD OF DIRECTORS OF GRAVELLY FORD WATER DISTRICT AND THE GFWD GROUNDWATER SUSTAINABILITY AGENCY AUTHORIZING ADOPTION OF THE GFWD GROUNDWATER SUSTAINABILITY PLAN 2025 PERIODIC EVALUATION

WHEREAS, no written, email or oral communications either for or against the GFWD Agency 2025 Periodic Evaluation have been received prior to this Public Hearing; and

WHEREAS, the Board President closed the Public Hearing at 1:08 PM; and

NOW, THEREFORE, BE IT RESOLVED, by the Board of Directors of the District and Agency accepts and approves the Gravelly Ford Water District Groundwater Sustainability Plan 2025 Periodic Evaluation as presented; and

BE IT FURTHER RESOLVED, that the Board of Directors of the District and the Agency hereby authorize the submittal of the GFWD GSP 2025 Periodic Evaluation to the California Department of Water Resources through the Madera Groundwater Subbasin prior to the January 31, 2025 filing date.
